Dean's Message



Bachelor of Integrative Studies (Individualised Major) [BIS (IM)]

The Bachelor of Integrative Studies (Individualised Major) is the first and only undergraduate programme in Singapore that empowers students to design and customise their own major! Students can enrol in courses of their choice from the various schools in SMU to form their unique degree programme.



Integrative Studies Core and Electives (16 CUs)

Students can opt to pursue the Professional Track or the Research Track:

(a) Professional Track

- Emphasis on workplace readiness and industry experiential learning
- High exposure to industry and societal problems, enabling students to better bridge the gap between their university studies and future employment

(b) Research Track

- Deep academic inquiry
- Suitable for students with an interest in policy, research, or academic-oriented career

Integrative Studies Core (4 CUs)

- **Methods Across Majors: An Interdisciplinary Introduction to Research**
- **Exploring Interdisciplinary Horizons: An Introduction to Integrative Studies**
- **Any two courses from the "Challenges" basket:**
 - Climate Change: Past, Present, and Future

 - The Human Condition: Who are we? What are we?
 - Thinking with Data

Coursework Electives (10 to 11 CUs)

CIS students will select courses relevant to their individualised major, including additional SMU-X courses and courses completed on exchange programmes.

Capstone Projects and Senior Thesis (1 to 2 CUs)

CIS students will choose to embark on a Capstone Project (Professional Track) or a Senior Thesis (Research Track) as a consolidation of their Bachelor of Integrative Studies (Individualised Major).

Industry Experiential Learning

All students on the BIS(IM) will complete industry experiential learning through SMU-X courses and/or Work-Study Electives.

Upon completion of programme, students will graduate with a Bachelor of Integrative Studies from SMU, and their academic transcript will reflect the specific name of their Individualised Major.

1:1 Mentorship



Interning with the **Banyan Group** was different.

Prior to it, I had always been stubborn that I only wanted to work for a charity or philanthropic foundation (where I did three internships in) because I loved making impact.

“It wasn’t until CIS offered this opportunity to work with an impact-centred firm, that I knew I couldn’t pass it up.

The internship changed my perspective on my aspirations. Through the experience, I realised that impact need not only be a word used in the social sector. It expanded my definition of impact, and how it could be integrated into for-profit firms. I realised I loved working for impact, regardless of whether it was a for-profit or non-profit firm.

The second shift for me was the realisation that I genuinely enjoyed working with data! I had always held the perception that I was never a “numbers girl!”. Interning with the Revenue Management and Strategy department taught me so much about extracting and telling stories with data. It gave me confidence in my ability to grow in what I thought was a weakness!

Thirdly, the stint changed how I fundamentally operated. In an internship where you often deal with numbers, clarity is key. I had to be clear in my communication, understanding, and priorities. I don’t think any internship has shaped my work ethic as much as this stint at Banyan Group has!

My biggest gratitude goes to not just my supervisor Limin, for taking a chance on me, but also to CIS for giving me an opportunity to try something different.

It’s exciting because I now have a second upcoming work-study elective with Openspace Capital, an asset management firm managing over USD \$800M! It’s again thanks to CIS that I’ll be interning with Hian Goh, the founding partner, who is also an advisory board member of the College of Integrative Studies. There, I’ll be supporting deal flows and partnerships.

If Year 1 me could look back, she would not believe the kinds of experiences Year 3 Jamie has now! CIS has not just been a school for me, but a launchpad for my growth.






BIS(IM) Final Year Senior Thesis/Capstone Project

CIS Postgraduate Programmes

MPhil & PhD in Asian Urbanisms

Our postgraduate programmes in Asian Urbanisms offer an opportunity to study cities in an interdisciplinary way. Students are primarily supervised by faculty from the College of Integrative Studies, with optional co-supervision from other SMU Schools, and will undertake coursework and independent research culminating in a dissertation. Graduates explore diverse topics, from changing food consumption to e-commerce economics, waste management, and sea-level rise. PhD graduates are prepared for academic and policy-related roles, while MPhil graduates gain skills for careers in research, policy, or consulting. With access to expert faculty, our students are well-equipped to address the most pressing urban issues in Asia.


